- 1. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Bhubaneswar reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements or otherwise.
- 2. This is a "**Rolling Advertisement**" and will be used to fill the unfilled posts by issuing subsequent notifications on the website https://aiimsbhubaneswar.nic.in/ and other details are as follows-
 - 2.1. This advertisement will be valid for one year from the date of publication of the advertisement in the Employment News/ Rojgar Samachar.
 - 2.2 The first cut-off date will be 30 days from the date of publication of the advertisement in the Employment News/Rojgar Samachar. In case the cut-off date falls on weekly off or holidays, then the cut-off date of submission of application will be shifted to the next working day (up to 5.00 PM).
 - 2.3 The vacancies, which will remain unfilled after completion of first selection procedure, will be notified along with the subsequent cut-off date on the Institute's website only. Hence, candidates who might not be fulfilling eligibility criteria as on the first cut-off date, but might be fulfilling the criteria in the subsequent cut-off dates, may keep looking for employment opportunities on the Institute's website.
 - 2.4 Age, educational qualification, experience & others will be counted as on the Cutoff date.
- 3. The Posts of Professor are to be filled up through either direct recruitment or deputation basis. However, application on deputation for the post of Professor will be considered in respect of those candidates who are holding analogous posts in any of the Institute of National Importance under Govt. of India. The application for deputation only should be routed through their employer and the same shall be sent along with attested copies of ACRs for last five years and Vigilance Clearance Certificate through Speed Post.
- 4. Relaxation of One-year Teaching/Research experience for SC/ST candidates in Faculty selection will be given as per Rules/Guidelines issued by DoPT.
- 5. Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The equivalent qualification such as M.Ch. in Hepato-Pancreatico-Biliary Surgery as equivalent to M.Ch. in Surgical Gastroenterology and other similar such qualification will be decided by the Competent Authority of AIIMS, Bhubaneswar and his/her decision in this regard will be final.

8. MAXIMUM AGE LIMIT & AGE RELAXATION:

- 8.1 Professor/Additional Professor: Not exceeding 58 (Fifty-Eight) years as on cut-off date.
- 8.2 Associate Professor/ Assistant Professor: Not exceeding 50 (Fifty) years as on cut-off date.
- 8.3 No age relaxation would be available to SC/ST/OBC/EWS candidates applying for unreserved vacancies.
- 8.4 Age relaxation permissible to various categories is as under:

8.5 Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions.

9. RESERVATION:

- 9.1 Reservation for SC/ST/OBC/EWS/PwBD will be as per Government of India Policy.
- 9.2 Candidates applying against any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered on production of valid Caste/PwBD/EWS Certificate issued by the Appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- 9.3 Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non-creamy layer) in the prescribed format issued by Competent Authority. The certificate should be of the current financial year and in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).
- 9.4 Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt. of India, Office Memorandum No. 36039/1/2019-Estt (Res) DoPT dated 19th January, 2019 and 31st January, 2019. EWS candidate must ensure that they have a valid EWS certificate as on the cut-off date. EWSs Candidates are required to attach certificate issued by the competent authority in the format prescribed as per guidelines of Govt. of India. In case suitable Economically Weaker Section (EWSs) candidates are not found, these posts will neither be carried forward nor considered as backlog vacancies. Therefore, Unreserved (UR) candidates are also provisionally allowed to apply against the posts reserved for EWS and they may be considered in case suitable EWSs candidate are not found to fill up these posts reserved for EWSs.
- 9.5 4% of the total vacancies are horizontally reserved for PwBD candidates as per the Ministry of Social Justice and Empowerment's Notification No. 16-15/2010-DD.III dated 29th July, 2013 as amended from time to time as applicable. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. However, the candidature of PwBD applicant is subject to evaluation by a Medical Board duly constituted by the Executive Director, AIIMS, Bhubaneswar. This Medical Board will evaluate suitability of candidates for the post he/she is being considered for. All the instructions of Govt. of India as amended and as applicable in this matter will be followed if the same is not consistent in this connection.

10. NO OBJECTION CERTIFICATE:

The applicants who are already in Government service (including AIIMS Employees) shall have to produce No Objection Certificate from their present employer at the time of Interview or as per the instructions issued from time to time. However, they have to take prior permission from their employer while applying for the post. No candidate will be allowed to appear for the interview without NOC from his employer.

11. PAY SCALE & ALLOWANCES:

11.1 All the posts carry usual allowances as admissible to Central Government Employees of similar status at Bhubaneswar, Odisha.

12. APPLICATION PROCESS:

- 12.1 The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the cut-off date of online applications failing which their application will be rejected. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
- 12.2 The aspiring applicants satisfying the eligibility criteria in all respect can apply through **ON-LINE** application mode only. The On-line registration of application will be made available on official website of AIIMS, Bhubaneswar i.e. https://aiimsbhubaneswar.nic.in/ The notification for date of activation of link for submission of online applications in respect of above said posts along with other relevant information will be notified on the website.
- 12.3 Candidates after applying through online mode must send the hard copy of duly signed online application form and self-attested copies of Matriculation Certificate, MBBS Degree Certificate/Mark-Sheets, MD/MS/DM/MCh or equivalent certificates/Mark sheets, Teaching/Research Experiences Certificates etc. in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc. besides others in support of their candidature to this Institute. Candidates must ensure that their hard copy of application & other relevant documents as mentioned above must reach in the Institute within 15 days from the cut-off date. - 12.6 Candidates are advised to fill their correct and active e-mail ID in the online application, as all correspondences will be made by the Institute through e-mail. Test/Interview schedule will be mailed in due course to the candidate in their registered e-mail.
- 12.7 The candidate must ensure that their photo and signature should be clearly visible in preview at the time of filling of application in online mode. If photo/signature image is displayed small or not visible in preview on website, that means photo/signature is not as per the AIIMS, Bhubaneswar prescribed guidelines and in that case, their application will be rejected. So, candidates are advised to be careful while uploading their photo and signature. Both must be visible clearly on Online Application Form.
- 12.8 In case a candidate wishes to apply for more than one post, he/she is required to fill in the form separately through On-line mode and separate application fees as applicable is to be paid.

13. APPLICATION FEES: Rs. 1,000/- (Rupees One Thousand Only).

- 13.1 **For Unreserved/OBC/EWS candidates is Rs.1000/-.** The candidates can pay the prescribed application fee online by clicking in the link provided in the website while filling up the Online Application.
- 13.2 Application fee once remitted shall not be refunded under any circumstances.
- 13.3 No application fee for SC/ST/PwBD/Women Candidates of any community.
- 13.4 Incomplete application(s) and application received without the prescribed fee would not be considered and summarily rejected. The decision of the Competent Authority of AIIMS, Bhubaneswar in this regard will be final.

14. SHORT LISTING/METHOD OF SELECTION:

The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on the application, the Screening Committee may short- list candidates for interview. If required there may be Screening test to shortlist candidates for interviews in case large number of candidates apply for a post or posts. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by the AIIMS, Bhubaneswar at time of Interview. The methodology of Selection will be decided by the Selection Committee as deemed fit besides any other matter relating to the selection process.

15. OTHER TERMS & CONDITIONS

- 15.1 **Site of Interview:** Interview will be held at AIIMS Bhubaneswar or any other place as decided by the Executive Director, AIIMS, Bhubaneswar. No TA/DA will be paid for appearing in the interview.
